Christian Academy HSS is a co-educational institution founded in 1999 starting with the Arts, Science & Commerce stream in the Higher Secondary level. The institution is a project sponsored by the Church of Jesus Christ and a natural progression of the Christian Academy Secondary level at Wahingdoh /Riatsamthiah. It has over the years consistently provided quality education and produced excellent results as well- for it believes that God raises up ordinary individuals to become extra-ordinary leaders.

Christian Academy which is located at Wahingdoh /Riatsamthiah, Shillong is the outcome of the vision of the founder President, (Late) Rev (Dr) R.J. Skinner of the Church of Jesus Christ. Established in 1983 it initially started with Nursery and Kindergarten and proceeded each year in the Secondary level. ### ADMISSION

Applications for admission, on prescribed forms, will be accepted immediately after the announcement of the Secondary School Leaving Certificate Examination Result of the

Meghalaya Board of Secondary School Education, and those who have passed their School Leaving Examination from any recognised Board. Each application must be accompanied by :

1. Attested copy of admit card and marksheet of the last examination passed.
2. A pass certificate and testimonial of character from the Principal of the School last attended.
3. Attested copy of Schedule Caste/ Schedule Tribe Certificate.
4. The original migration certificate for those students coming from Boards other than the Meghalaya Board of School Education is to be handed over to the office not later than one month from the date of admission.

### EXAMINATIONS

The Institution conducts regular test : The marks secured by the students at these tests are taken into consideration at the time of selection for the Board Examination.

Selection of students for admission will be at the discretion of the management, within the prescribed norms.

### ATTENDANCE

Daily attendance is compulsory for all students. A minimum of 80% attendance is required if a student is to be sent up for the Board Examination.
